All PRC Residents Must Be Present and In-House To Receive Property

Property Drop-off Times:

Tuesdays 5:00pm - 8:00pm / Fridays 12:00pm - 3:00pm

INITIAL DROP-OFF Upon transfer to PRC, new resident intakes are allowed to have family members drop off: Clothes, undergarments and cosmetics only. **No TV's** are allowed at this time.

SECOND DROP-OFF After a resident has been at PRC for 30 days, a second property drop-off can include: Clothes, undergarments, a TV (brand new in a box with cable wire), and cosmetics.

THIRD and SUBSEQUENT DROPS After a 30 day drop-off of property, family members are only allowed to make another drop-off every 90 days.

Restrictions:

- NO camouflage on any clothing or coats
- NO sports logo or team names on any clothing or coats Small Print Brands or Logos are the only exception
- Clothes must be laundered. Property will be searched
- WMCAC residents may transfer with a TV. TV's will be denied if they have been tampered with or not in good condition
- Residents can request to have additional property on a case by case basis. Requests must be approved by a Unit Manager or an on-duty supervisor
