# DESCRIPTIVE OVERVIEW OF THE 2015 RELEASE COHORT

## Executive Summary

At the end of each year, a descriptive overview is prepared of those offenders released during the year. This allows us to monitor any changes in the population and track trends from year to year. Data is used for population management and program development.

Sentenced offenders released to the street will be tracked for three years post release as part of our ongoing recidivism study. Recidivism rates are reported at one and three-year intervals.

There were 5896 total releases from the facilities operated by the Hampden County Sheriff's Department in 2015 (2030 females, 3866 males). This represents an overall increase of 527 (9.8%) from 2014.

A total of 1906 sentenced offenders were released (502 females, 1404 males), a decrease of 249 (11.6%) from 2014. 1763 sentenced offenders (487 females, 1276 males) were *released to the street* via parole or expiration of sentence, a decrease of 52 from the previous year. 107 sentenced offenders were released to other authorities. There were 50 releases from Foundation House (7 women, 43 men) and 3 HOPE parole releases (both men). 165 sentenced offenders (37 women, 128 men) were released back to the jail to address open charges.

A detailed analysis of sentenced offenders released to the street can be found in **Section I**.

There were 3814 pretrial releases (1488 females, 2328 males), an increase of 19% from 2014. 3308 pretrial detainees were *released to the street* via bail, release at court or sentence to time served (1442 females, 1866 males). 483 detainees were released to other authorities and 23 probates purged or paid their debt and were released. One female and one male pretrial detainee died in custody.

A detailed analysis of the pretrial release cohort can be found in **Section II**.

198 individuals (8 females, 190 males) received a sentence to Mass DOC and were transported to MCI Framingham or MCI Cedar Junction. 10 males and 1 female were transferred to a DOC facility for a reason other than a new sentence or VOP. These reasons included commitment to Bridgewater State Hospital, DOC Reentry Program failure or court appearance on existing case.

## **SECTION I SENTENCED RELEASES TO THE STREET**

### **Summary**

#### Number and Gender

The breakdown by gender was 1276 males and 487 females, representing 72% and 28% of the total population, respectively.

The 1276 sentenced males released to the street in 2015 represented a decrease of 100 (7%) from 2014.

The 487 sentenced females released to the street in 2015 represented an increase of 48 (11%) from 2014.

The release cohort represented 1671 unique individuals (1219 males, 452 females). 53 males and 35 females were released twice during 2015, 2 males were released three times.

#### Race and Ethnicity

The racial and ethnic breakdown is different for males and females. 81% of women identify themselves as Caucasian, 11% as Hispanic and 7% as African American.

In contrast, 40% of men identify themselves as Caucasian, 44% as Hispanic and 16% as African American.

#### Age

The mean age of the female population is 34 years, 124 days; the mean of the male population is 35 years, 168 days.

14% of females and males are under age 25. 24% of females and 30% of males are over age 40.

Most common age for women is 28, for men 27.

### Criminogenic Factors

28% of females and 49% of males lacked a high school diploma or equivalent at intake.

80% of females and 70% of males were unemployed at time of incarceration.

73% of females and 81% of males admit having criminal associates.

84% of women and 89% of men were identified as having a substance abuse problem.

### Residence

84% of males and 33% of females provided a Hampden County address at intake. Worcester County residents now represent 25% of the sentenced population at WCC.

53% of Hampden County offenders gave a residential address in Springfield, 16% Holyoke and 9% Chicopee.

Neighborhoods accounting for the largest number of offenders from Springfield were Mason Square (01109) and Forest Park (01108) with 24% and 21% respectively, and Central (01105) 19%.

40 offenders (17 females, 23 males) failed to provide an address at intake.

### Governing Offense

17% of women and 29% of men were serving sentences for violent offense(s). 61 offenders were serving a sentence for a technical violation of parole. 80% of technical violators were nonviolent offenders.

### Sentence

Mean sentence for women was 195 days (6 months, 15 days), for men 303 days (10 months, 3 days). Most common sentence for both genders was 180 days.

Females served a mean of 127 days (65% of sentence). Men served 211 days (70% of sentence).

134 women (27.5%) were sentenced to 60 days or less. 70 (14%) were sentenced to a year or more. For men, 206 (16%) had sentences of 60 days or less, and 449 (35%) were sentenced to a year or more.

Mandatory days sentenced totaled 38,475, a decrease of 8721 days from 2014. This can be attributed to the continued decrease in school zone offenses.

### Classification

The female release cohort included 474 county inmates, 5 DOC, 6 Bureau of Prisons and 2 Probates. 31% of county releases were from Worcester County, 35% from Hampden County.

The male release cohort consisted of 1156 county inmates, 64 DOC, 35 Bureau of Prisons or US Probation and 21 Probates.

43% of women and 53% of men were released from lower security. 203 men attained minimum status in the Community Reentry Unit.

### Release Type

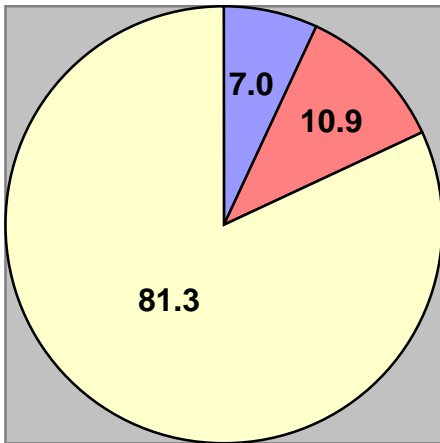
Paroles accounted for 13.4% of releases in 2015, down from 14.5% in 2014.

Parolees served approximately 54% of their original sentence compared to 73% for those who completed their sentence.

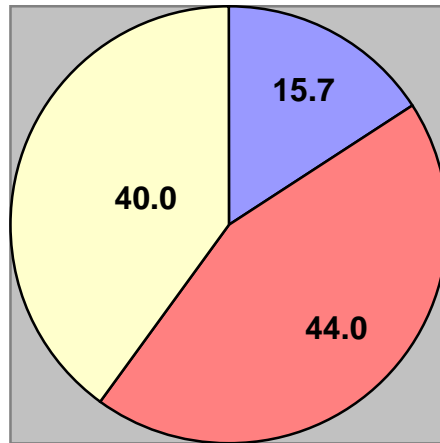

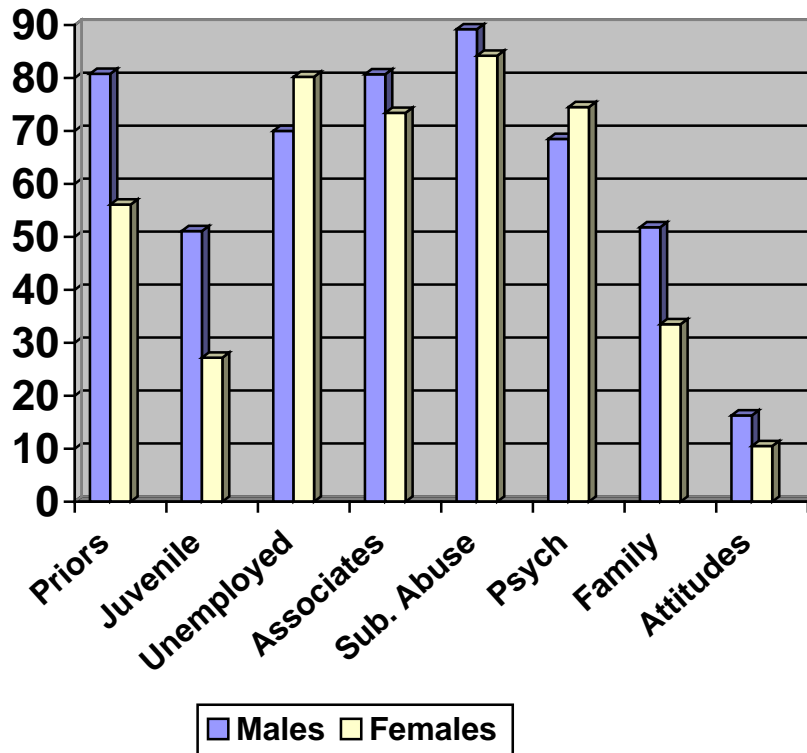

**Risks/Needs by Gender**

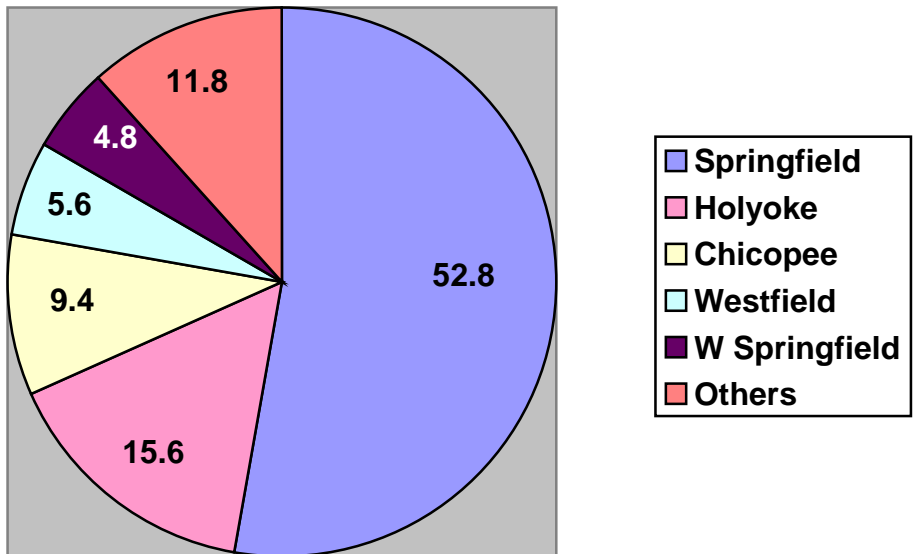

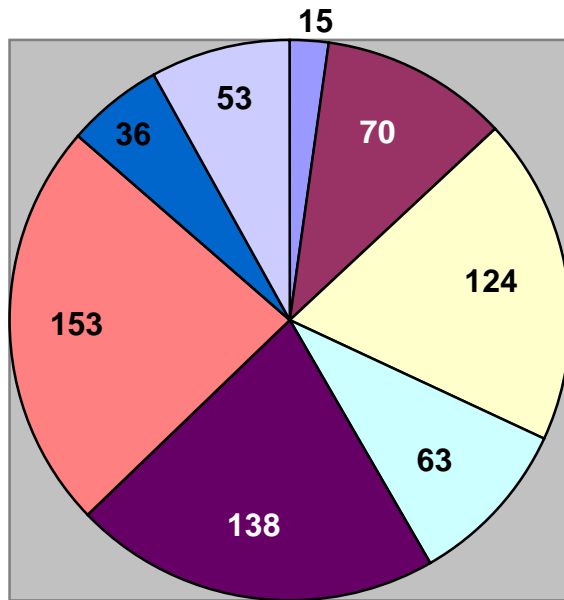

## **SECTION II PRETRIAL RELEASES TO THE STREET**

### **Summary**

#### Number and Gender

There were 3308 pretrial releases to the street in 2015, 1442 females and 1866 males.

The group represented 2845 unique individuals (1177 females, 1668 males). 158 males and 147 females were released twice during the year, 13 males and 33 females were released three times and 4 males and 15 females were released four or more times.

878 (26.5%) were bailed, 2298 (69.5%) were released at court and 132 (4%) were found guilty and sentenced to time served.

#### Race and Ethnicity

As with the sentenced population, the racial and ethnic breakdown is different for males and females. 9% of females and 20% of males identify themselves as African American, 12% of females and 45% of males as Hispanic, and 78% of females and 35% of males as Caucasian.

#### Age

Mean age for pretrial women was 32 years, 120 days and for men 32 years, 281 days. Most common age for men was 22, for women 27.

23% of females are under age 25 compared to 26% of males.

Overall, the pretrial population is younger than the sentenced population.

## Residence

10% of females and 47% of males gave a Springfield address at booking. 3% of females and 11% of males were from Holyoke and 4% of females and 8% of males were Chicopee residents. 43% of females came from Worcester County.

349 pretrial detainees provided no address at intake.

## Release

2240 (68%) of pretrial releases were from Hampden County courts, 33% from Springfield District Court, 703 (21%) releases were from Worcester County courts.

1039 (31%) were being held on bail of \$2000 or less, 41 of whom were ultimately sentenced to time served. 1669 detainees held without right to bail were released at court, and 60 were sentenced to time served.

## Governing Offense

1231 (37%) of pretrial releases were held on violent charges. 386 were bailed, 794 were released at court, and 51 were sentenced to time served.

384 had outstanding warrants and detainers dismissed at court.

## Time in Custody

Mean time in custody prior to bail was 23 days. 63% were bailed in the first 10 days and an additional 18% were bailed within 30 days.

Mean time to release at court was 30 days. 42% were released in the first 10 days and an additional 32% within 30 days.

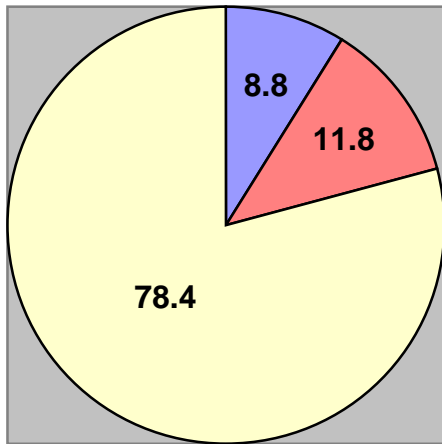
For those sentenced to "time served", the mean was 79 days. 54 (41%) served 30 days or less, 31 (24%) served 31-60 days. 14 individuals served more than 180 days prior to disposition.

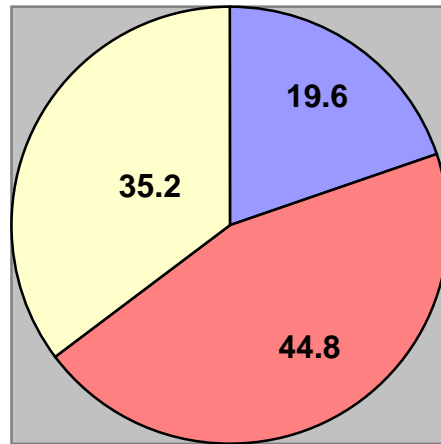

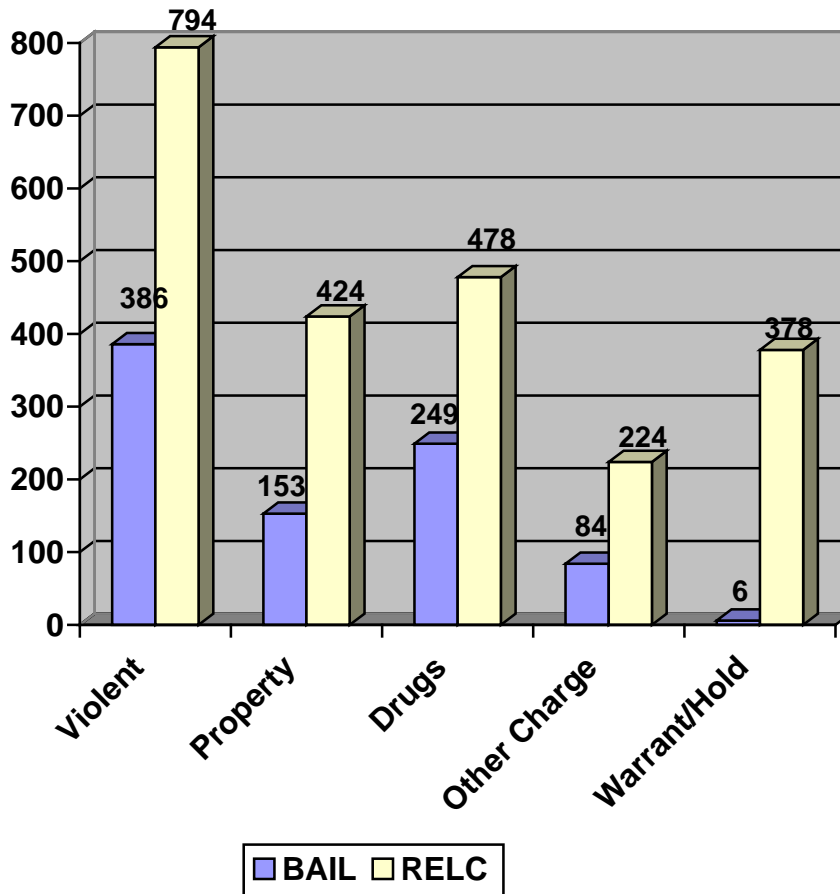

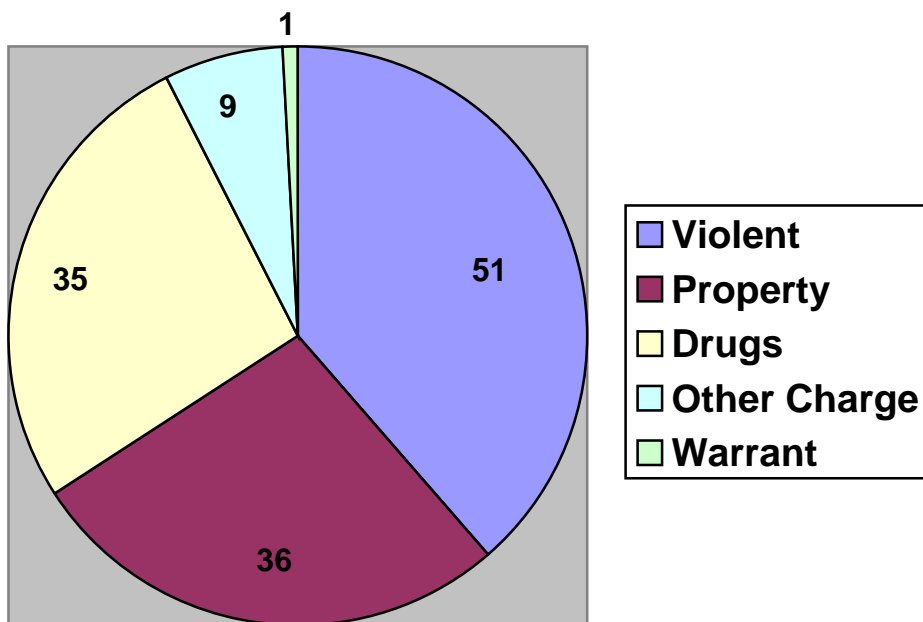
**Governing Offense by Release Type**

## **SECTION III OFFENDERS SENTENCED TO DOC**

### **Summary**

There were 198 sentences to Mass DOC in 2015, 8 females and 190 males.

These individuals were overwhelmingly minority (21% African American and 56% Hispanic).

42% were under age 30.

84 (42%) were sentenced for a nonviolent crime, 95 (48%) for a violent crime and 19(10%) for a parole violation.

Mean time to disposition for a nonviolent case was 291 days, for a violent non-murder case, 369 days.

6 men and 2 women were sentenced on charges of murder or manslaughter. One man received a life sentence. Mean time to disposition was 604 days.

10 men were sentenced for a sex offense. Mean minimum sentence was 6.75 years.

The most common sentence for a nonviolent offense was 3 years to 3 years and a day.

Most common sentence for a violent offense was also 3 years to 3 years and a day.

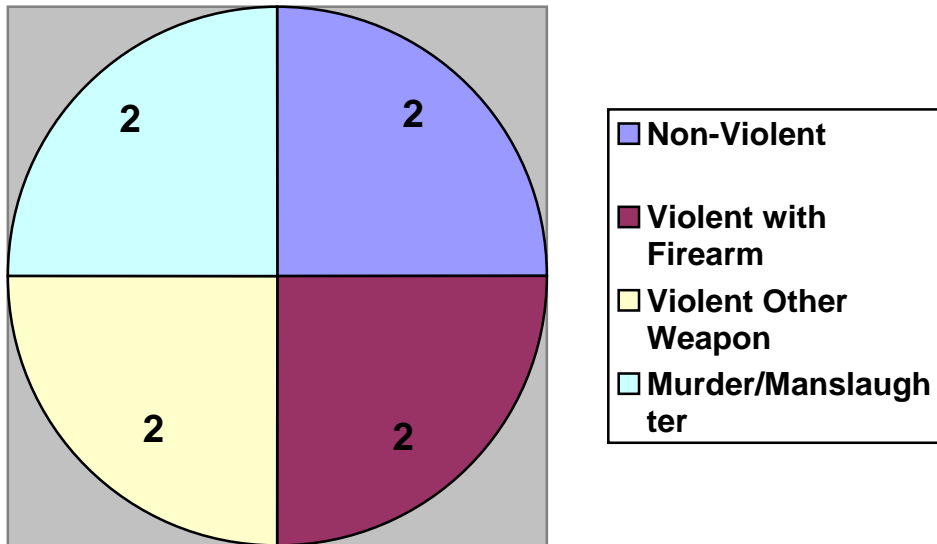
