Security Gate and Pavement Repair

The Hampden County Sheriff's Department, the Awarding Authority, invites sealed bids from Contractors for security gate and pavement repair at the Western Massachusetts Regional Women's Correctional Center, 701 Center Street, Chicopee, MA 01030, in accordance with the documents prepared by Timothy Murphy Architects.

The Project consists of: modification of, and new foundations for, an existing chain-link fence sliding gate. Removal and replacement of bituminous concrete pavement and driveways. Removal and replacement of unsuitable soil if present.

Project No. WCC2017-01 Contract No. SDH2017-01. The work is estimated to cost \$75,000.

Bids are subject to M.G.L. c.30 §39M & to minimum wage rates as required by M.G.L. c.149 §26 to 27H inclusive.

Bids will be received until 2:00 P.M., Wednesday, April 12, 2017 and publicly opened, forthwith.

Bids shall be accompanied by a bid deposit that is not less than five (5%) of the greatest possible bid amount in the form of a certified treasurer's or cashier's check payable to the Awarding Authority from a responsible bank or trust company; cash; or a bid bond from a licensed surety.

The Successful Bidder shall provide the Awarding Authority with a Payment or Labor and Materials Bond in the form provided by the Awarding Authority, executed by a surety company licensed by the Commonwealth of Massachusetts' Division of Insurance and whose name appears on United States Treasury Department Circular 570. The Payment Bond shall be in an amount equal to 50% of the Contract Sum. A Performance Bond is not required.

Bid Forms and Contract Documents will be available for pick-up at Hampden County Sheriff's Purchasing Department, Room 252, 627 Randall Road, Ludlow, MA 01056 on Wednesday, March 22, 2017 & thereafter Monday through Friday between the hours of 9:00AM – 4:00PM. Contact Ann Speziali at 413-858-0119.

There is a plan deposit of \$50.00 per set (maximum of 2 sets) payable to the Awarding Authority.

Plan deposits must be a certified or cashier's check. This deposit will be refunded for up to two sets for bidders upon return of the sets in good condition within thirty days of receipt of bids. Otherwise the deposit shall be the property of the Awarding Authority.

Additional sets may not be purchased.
